**Board of Directors' Meeting Minutes**

Paulette Marshall called the meeting to order at 3:04 p.m. MST.

**3. EVENT REPORTS.**

**C. LATIGO - AUGUST 3 & 4.** Paulette reported that she was having difficulty nailing down clinicians for this event. Lavert Avent is confirmed as a judge on Sunday. She will contact Kyle Trahern or Lori Walton for the other position. If needed, JG Marshall can cover the cattle clinic. These August dates conflict with fair schedules – may check to see if moving event to the following weekend is better.

**D. T-CROSS RANCH - SEPTEMBER 7 & 8.** Paulette reported the event is set with Jay and Gina Henson as clinicians/judges.

**E. CACTUS CREEK RANCH – OCTOBER 12 & 13.** Plans are still up in the air. The facility is confirmed; considering Kyle Trahern or Amy Lasatz as clinician/judge.

**4. CLOTHING LINE.** Paulette Marshall presented the Board with a box of CoVRHA logo wear samples sent by Lynn Cool, who was unable to attend the meeting. The Board agreed that the logo wear be available for purchase on an individual basis rather than having stock on hand. Cori will look into making the logo wear available for purchase on the website.
